

FULL FACE MASK

Model PANAREA Code 7000

PANAREA full face one-size-fits-all mask is a negative pressure mask, in compliance with European standard EN136:1998 and in accordance with directive 89/686/EEC, consisting of:

Outer seal in soft silicone, extremely delicate on skin and extremely flexible at both high and low temperatures, guaranteeing a hermetic seal on any face shape.

Polycarbonate wide screen with anti-scratch treatment on the outside and anti-fog system on the inside, distortion free; its 180° angle ensures a wide field of view both horizontally and downwards. The polycarbonate, of which it's made of, is 2,2 mm thick to ensure high impact resistance.

The valve group combines in itself the universal thread EN 148-1, the exhalation valve, the phonic diaphragm, the inhalation valve, and the valve seal door.

Inner oronasal mask in hypoallergenic silicone.

5 point head harness in EPDM rubber.

The mask can be used with filters having a universal thread EN 148-1, especially EURFILTER series 7000.

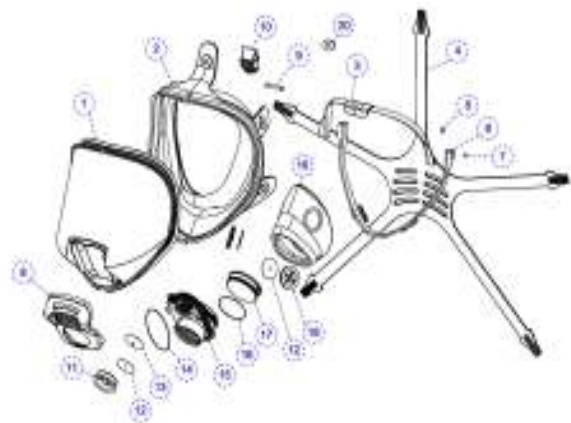
The position and inclination of the threaded connection is designed in such a way that, when the filter is placed in the mask, this does not interfere with the visual field of view, and its weight is more ergonomically distributed.

PANAREA full face mask is suitable, among other, for the protection against highly noxious fine dusts, organic, inorganic and acid gases and vapours, and gas and dust combinations. It finds best use in the chemical industry, pesticide application, forest fire smoke, asbestos treatment and disposal, presence of radionuclides.

Inward loss of seal: less than 0,0012%

Storage: store product at temperature between -20°C and +50°C, with no more than 80% relative humidity.

Expiration date:

When properly stored in its original package under the prescribed conditions, the mask has an expected lifetime of 10 years from date of manufacture. The expiration date is indicated on the box label.

Use limitations: this filtering device cannot be used in environments, where oxygen concentration falls below 17% in volume. The mask cannot be used with overpressurised flow apparatus, and with filters that are not provided with the same universal connection EN148-1.
